These shows are operated in accordance with the current rules of the WASHINGTON STATE HORSEMEN Horse Show Division and are "B" System Shows. Every Class offered herein which is covered by the rules and specifications of the current WSH Rule Book will be conducted and judged in accordance therewith. It is the responsibility of each Exhibitor to become familiar with the rules before entering the ring. Every entry at these WSH Recognized Competitions constitutes an agreement that the person making it, Owner, Lessee, Agent, Coach, Manager, Trainer, Driver, Handler, Rider, and the Horse, are subject to the By-Laws and rules of WSH. AGE: The age of exhibitor: For horse show purposes, the age of the exhibitor on December 1 shall be maintained the entire year. Persons born on December 1st, assume the greater age on that date. A junior has not reached his/her 19th birthday on December 1. A senior is 19 years or over on December 1st. For horse show purposes, a horse becomes 1 year older on January 1st, following the actual foaling date. A junior horse is one that is five years of age or younger, a senior horse is six years of age and over.

AMATEUR CLASSES: To enter any Amateur designated class, a current AQHA, ABRA, AMHA, APHA, APHA, APHA, NRHA, USE, WSH Amateur or Non-Pro Card is required. WSH will issue Amateur Cards for an annual fee of \$12; the fee for WSH Members is waived if participating in two (2) WSH Annual High Score Awards (does not mean Zone Awards). An application for a WSH Amateur Card can be made at the Show Office. Please include a photocopy of your card with your entry or bring a photocopy to the Show Office to be left on file with your entry; presenting your original card for review is no longer an option. Entry into any Amateur designated class will not be processed until the required photocopy or a completed WSH Amateur Card Application with paid fee has been received. Photocopies must be submitted at each show.

AWARDS: Prizes to 1st Place, ribbons to 6th place in all classes. Ribbons to all Leadline Exhibitors.

BREED CLASSES: Horses must be entered using their full registered name (and show name if different) for any breed class. Please include a photocopy of your horse's registration papers with your entry or bring a photocopy to the show office to be left on file with your entry; presenting your original papers for review is no longer an option. Horses entering an All Other Breeds class as a second Breed must have photocopies of all registration papers on file in the Show Office; see the All Other Breeds Division Rules for more information. Entry into any breed class will not be processed until the required photocopy has been received. Photocopies must be submitted at each show.

CHANGES: Show Management reserves the right to cancel or combine classes when it does not affect WSH points. Exhibitors will be notified if classes are combined or canceled.

CLASS ENTRIES: Out of respect for office staff, class entries and scratches are required to be made at least three (3) classes in advance and will not be accepted at the gate. Entries for the Showmanship and 4H Member Fitting & Showing classes at both shows will close 15 minutes before the start of the morning session.

CONDUCT by WSH Members, Non-Members, Exhibitors, Trainers, Owner's Representatives, Spectators, and all other persons present on the show grounds shall be orderly, responsible, sportsmanlike and humane in the treatment of their horses. Unsportsmanlike or irresponsible conduct, or any other form of misconduct that is illegal, indecent, profane, intimidating, threatening, harassing, or abusive is prohibited, as is the inhumane treatment of horses. Show Management may immediately expel offenders from the show grounds, forfeiting all prizes and awards with no refund of fees paid. Show Management reserves the right to refuse any entry of an exhibitor or the participation of an agent, trainer, rider, or driver who has shown an objectionable attitude toward a recognized show or previous unsportsmanlike behavior at a recognized show or to its management. They may ask anyone on the grounds to leave at any time for any reason. This is a private function, and you may be asked to leave and are expected to vacate the premises immediately if asked.

DOGS must be always on a leash and away from show arenas, regardless of if you are showing or not.

ENTRY FEES are non-refundable for missed or scratched classes and will not be deducted from the amount owing on Open Checks. Exhibitors will be allowed to transfer entry fees from one class to another provided the trade is submitted to the show office on the appropriate form at least three (3) classes prior to the first class being traded. Entry Fees for classes entered during the show must be paid for at the time of entry unless a signed, blank check (open check) is on file in the show office prior to entering.

ENTRY FORMS must be plainly printed or typed and signed by Owner or Authorized Agent, the Rider/Driver/Handler, and any Coach or Trainer. Parent or Guardian signature is required if the Rider/Driver/Handler is a Junior Exhibitor. Exhibitor Numbers will not be released until all required parties have signed the Entry Form. Entries will not be accepted without payment of all applicable Class Entry, Post Entry, Camping or RV, Office, and Stall or Haul-In fees. Open Checks cannot be accepted as payment for initial entries. Please circle only those classes you are submitting payment for. Riders/Drivers/Handlers sharing the same Horse must each be entered in the show on a separate entry form. Please include photocopies of your: 1) WSH Membership Card, 2) Current ABRA, AMHA, APHA, APHC, AQHA, PtHA, NRHA, USE, WSH Amateur or Non-Pro Card if entering Amateur designated classes, and 3) Horse's registration papers if entering Breed classes. Please pay only one Stall and/or Tackroom, Dry Camp or RV-Hook-Up per Entry Form; please do not split fees or pay another exhibitor's fees on your entry.

EXHIBITORS must appear in the ring suitably attired, with correct number on their backs or on each side of the saddle pad, clearly visible to the Judge at all times when in competition. Exhibitors in any 'In Hand' class may wear their number in front. Entries with wrong/missing numbers will be disqualified. **NUMBERS MUST BE VISIBLY NOTICEABLE FROM ACROSS THE ARENA.** 

FRANKLIN COUNTY SADDLE CLUB: Due to insurance liability issues, Exhibitors may not be on the grounds before noon Friday, and only horses entered in the show are permitted on the show grounds. An Entry Form must be signed and fees paid before horses can be exercised or stabled on the grounds.

GATE HOLDS for tack/attire or horse/rider changes are to be requested at least three (3) classes prior. Gate Holds are limited to a maximum of three minutes and are granted only when Horse and/or Rider/Driver/Handler are in consecutive classes. In classes where horses compete collectively, the in-gate will not be closed any sooner than two minutes after the last horse exits the ring from the previous class unless all entries for the next class are present.

No horse will be allowed to enter the ring once the gate is closed.

HAUL-IN FEES: \$6 per day per horse for all horses not stabled on the grounds.

HIGH POINT AWARDS (SHOW & SERIES): Award & ribbon to Champion and Reserve. Points are counted on single Horse & Rider combination only. All exhibitors entered in the show will have points automatically counted from all designated point earning classes; exhibitors entered in both the Springtime Open and Summerfest will have points automatically counted from both shows from all designated point earning classes. See the Class Point Chart posted on our website and at the Show Office. Horses must be entered in

at least one breed class for points to be counted for Breed High Point Awards. In case of a tie, the winner will be the entry with the fewest classes of all point classes entered, shown and judged in. Points will be counted as follows:

JUDGE: All decisions of the Judge(s) are final. No Exhibitor/Owner/Trainer may approach any judge with regard to a decision unless he/she first obtains permission from the show committee or Steward who shall arrange an appointment at an appropriate time and place.

- Assumption of Risk and Waiver: Participant understands and accepts the risks of engaging in Equine Activities, while mounted or unmounted, as well as merely being near a horse, pony, mule, donkey, or hinny (collectively "equine"), include, but are in no way limited to, faulty equipment or tack that cause injury or death, Released Parties' failure to make a reasonable effort to determine the ability of Participant to engage safely in an equine activity or to safely manage the particular equine provided based on Participant's representations of his or her ability, Released Parties' failure to conspicuously post warning signs of a dangerous inconspicuous condition on the real property, as well as: (1) the propensity of an equine to behave in a way that may result in injury or death to a person on or near it (ex.: jump, run, kick, buck, bolt, spin, rear up, strike, bite, stumble, fall, etc.); (2) the unpredictability of an equine's reaction to a sound (ex.: doors opening and closing, snow and ice falling, rain, wind, thunder, voices, music, guns, planes, cars, trucks, etc.), movement, or unfamiliar object (ex.: machinery, equipment, obstacles, buggies, carts, barrels, ground poles, cones, flowers, flags, golf carts, mini-bikes, whips, bats, construction material, etc.), person or animal (ex.: leashed or unleashed dogs, ducks, wildlife, equines, etc.); (3) a collision with an object or another animal (ex.: mounted equine, loose equine, etc.); (4) the potential for a person participating in an equine activity to act in a negligent manner, to fail to control the equine or to not act within his or her ability; and (5) natural hazards, including surface and subsurface conditions (ex.: ground holes, uneven terrain, slippery or deep footing, etc.). Participant agrees that engaging in Equine Activities under this Release includes, but is in no way limited to, those defined in the Washington Equine Activity Liability Statute, WA ST 4.24.530 et seq., as well as riding another's equine, petting, guiding, leading, mounting, feeding, watching, and otherwise interacting with or merely being in the vicinity of equines (collectively "Equine Activities"). Participant understands the injuries, death, loss, and damage that may result from the inherent risks of engaging in Equine Activities or just being near equines, that equines are powerful and have the potential to be dangerous, even without warning, and that the risks listed in this Release is just a sampling and Participant is not relying on Released Parties (defined below) to list all possible equine-related risks. Participant understands that Washington State Horseman Horse Show Division ("WSH HSD") requires the wearing of an ASTM/SEI-certified equestrian helmet ("Helmet") consistent with the Washington State Horsemen rules. Participant understands and agrees that failing to wear a Helmet while engaged in Equine Activities increases the risk of serious injury and/or death, Participant is not relying on Released Parties to provide a Helmet, check a Helmet or its harness strap for proper fitting, or monitor the wearing of a Helmet at any time now or in the future. Participant understands and agrees that Participant has other riding associations and facilities to choose from, he/she has inspected the facility for the Equine Activities and is satisfied that all are reasonable and safe for Participant's intended use, he/she is voluntarily engaging in Equine Activities, he/she is directly and intentionally engaging in and assuming the risks of Equine Activities, and he/she agrees to at all times to be responsible for his/her personal safety. Participant agrees to purchase and maintain his/her health and liability insurance, remain responsible for his/her medical expenses, and waives his/her right to any claims arising from his/her participation in or observation of any Equine Activities, being near equines, or merely being present on real property owned, leased, rented, borrowed, visited, or otherwise occupied or utilized by Released Parties. "Released Parties" herein includes the Washington State Horseman Horse Show Division, its members, officers, directors, employees, contractors, and their respective family members, heirs, agents, trustees, beneficiaries, employees, working students, volunteers, independent contractors, clinicians, guests, visitors, invitees, partners, members, managers, officers, directors, owners, lessors, lessees, licensors, licensees, and others acting on their behalf.
- 2. **Release, Hold Harmless, Defend, Indemnify:** Participant agrees to release, hold harmless, defend, and indemnify Released Parties for any illness, injury, death, damage, or other loss (collectively "**Loss**") incurred by Participant or to Participant's property and/or equine, even if such Loss is caused in whole or in part by negligence or other fault of Participant or Released Parties (except gross negligence, or reckless or willful and wanton conduct). This Release shall not expire and shall remain in full force and effect in perpetuity.
- 3. Governing Law, Jurisdiction, Time/Liability Limitation, Attorneys' Fees, Jury Waiver: This Release shall be construed and enforced in accordance with the laws of the State of Washington. All disputes relating to the interpretation and enforcement of this Release shall be resolved by the state court in Pierce County, Washington. Participant agrees that any and all claims for Loss by Participant against Released Parties must be brought within one (1) year of the date accrued andany surviving claim for personal property Loss is limited to two hundred and fifty dollars (\$250). Participant agrees to reimburse Released Parties for any and all attorneys' fees and costs incurred by Released Parties in enforcing the terms of this Release and/or in defending or prosecuting any claims or causes of action involving or relating to Participant. Participant agrees to waive trial by jury in any action with Released Parties.
- 4. **Severability, Modification:** If any provision of this Release is deemed invalid or unenforceable, the remaining provisions shall be valid and enforceable to the fullest extent of the law. The Release can only be modified if signed by Participant and WSH HSD Director.
- 5. **Certification:** Participant certifies he/she read this Release and understands that signing this Release is required for Participant to participate in Equine Activities with Released Parties, knows that he/she has other instructors, facilities and/or horses to choose from, and voluntarily intends on his/her own behalf, and on behalf of minor Participant, and Participant's spouse, parents, family members,

heirs, agents, trustees, beneficiaries, representatives, successors, and assigns, to be bound by the terms and conditions contained herein.

OFFICE FEE: \$10 per Entry (Horse & Rider combination) for Springtime Open / \$15 per Entry (Horse & Rider combination) for Summerfest. Riders entered only in Leadline, Walk/Whoa or 10 & Under classes will not pay the office fee.

OPEN CHECKS <u>cannot be accepted as payment for initial entries</u>. They are a courtesy for exhibitors that have already paid to enter the show who intend to enter additional classes during the show, with the understanding that classes once entered will be charged, and that missed or scratched classes will not be deducted from any amount owing.

POST ENTRY FEE: \$10 per Horse for Springtime Open / \$15 per Horse for Summerfest. Entries postmarked by the Entry Closing Date and pre-entered in at least 1 class do <u>not</u> pay the Post Entry Fee. Riders entered <u>only</u> in Leadline, Walk/Whoa or 10 & Under classes do not pay the Post Entry Fee.

PROTECTIVE HEADGEAR: It is compulsory for all Junior Exhibitors 18 & under riding in hunter attire; Leadline Equitation Riders 6 & Under (any seat); and to wear properly fastened protective headgear which meets or exceeds ASTM/SEI standards when mounted anywhere on the competition grounds. No rider of any age will be penalized for wearing protective headgear in Western classes.

PROTESTS must be made in writing, signed by the protester, accompanied with a \$50 deposit, and addressed to the secretary of the competition within 48 hours of the alleged violation; OR may be made directly to the horse show Director, accompanied by the \$50 deposit, and received within five (5) business days following the last day of the competition.

REFUND OF ENTRY FEES (minus the Office Fee) will only be made upon receipt of a Physician's or Veterinarian's Certificate, stating the nature of the disability, and presented prior to rider's or horse's first class. Refunds will be mailed after the show.

RETURNED CHECKS: \$50 charge for checks returned for any reason.

RV HOOK-UPS: There are 36 electrical Hook-Ups, water is available but not for hookup. Grounds open from Friday Noon through Sunday 6:00pm. The electrical hookups will be available first come first serve and is \$30 per night. *Please note: Hook-Ups will only support basic electrical needs so please be considerate of your fellow exhibitors and not over-load the system.* Overnight camping (tent) and RV parking without hook-up is permitted for \$15 per night. Restrooms with showers are available on the grounds.

STABLING: There are 100 permanent box stalls (with full doors) on the grounds. Stalls are available from Friday noon through Sunday at 6:00 pm and one bag of shavings is included. The fees are \$25 per night, all stalls must be cleaned prior to leaving the grounds. Exhibitors may pay a \$20 cleaning fee per stall in lieu of cleaning stall. No stalls will be reserved without a completed entry form accompanied by payment of all applicable fees. Additional bedding must be paid for in advance of delivery to your stall. Those desiring adjacent stalls must indicate and, if possible, submit entries together. All Horses on the grounds overnight must be stalled. Miniature Horses and Ponies may be stabled two (2) per stall.

WSH MEMBERSHIP CARDS & NON-MEMBER FEES: Please include a photocopy of your Membership Card with your entry. Members who do not include a photocopy of their cards with their entry and are unable to present their card at the show office must pay the \$3 WSH Non-Member Fee per judge/per show. A Horse Owner or Non-Owner Equitation Rider/Showmanship Handler who is not a WSH Member must pay the \$3 Non-Member Fee per judge/per show; only one fee per owner is required to be paid regardless of the number of equines owned or shown. Exhibitors under the age of 18 may show a family-owned equine as "Owner" and the registered owner is not required to be a WSH Member or pay the Non-Member Fee. A family member is defined as: Parent, Aunt, Uncle, Grandparent, Sibling, Niece, Nephew, Cousin, or Legal Guardian; Step Parents, Aunts & Uncles, Grandparents and Half or Step Siblings included.

4-H/WAHSET/OHSET MEMBER CLASSES: Exhibitors must be current members of an active 4-H Club, or a Washington High School or an Oregon High School Equestrian Team.

AMATEUR: Exhibitors 19 years & over who do not accept remuneration for: 1) Riding, driving, showing in halter, training, schooling, or conducting clinics or seminars; 2) Giving instruction in equitation or horse training; 3) Receiving prize money for showing in Equitation classes. (Exception: County Fairs and classes that offer Scholarship Bonds).

### 4-H/WAHSET/OHSET MEMBER CLASSES

Performance, knowledge of horsemanship, attitude of the member, and condition of equine and tack will be taken into consideration. Riders are required to wear an ASTM/SEI approved helmet in all under-saddle 4-H/WAHSET/OHSET classes. English Pleasure and Equitation classes may be ridden in either Hunter Seat, Saddle Seat, or Dressage tack and attire. Chaps are optional in the Western Pleasure and Equitation classes.

### 4-H/WAHSET/OHSET Fitting & Showing (No WSH Pts.)

May show in Hunter attire with appropriate hunt bridle, Saddle Seat attire with appropriate bridle or show halter, or Western attire with appropriate show halter. Whips are not permitted. Exhibitors will be asked to demonstrate their ability to lead, turn, set-up, and

move their horse as the judge requests. Individual tests may include backing, forehand or haunch turns, sidepass, lead at the walk or jog/trot from either side, stop and set-up. The Quartering System will be used.

### 4-H/WAHSET/OHSET English Equitation (No WSH Pts.)

Exhibitors enter the arena at the trot and will perform both ways of the ring at the walk, trot, and canter. The order to reverse for Exhibitors riding Hunter Seat must be executed by turning away from the rail; Exhibitors riding Saddle Seat may reverse by turning either to or away from the rail. Exhibitors may be asked to perform a specific test or pattern; tests or patterns may consist of but are not limited to the following: extended or sitting trot, hand gallop, figure eights or serpentines at the trot or canter, back, halts, dropping irons, picking up reins in line.

### 4-H/WAHSET/OHSET English Pleasure (No WSH or NEZ pts.)

Horses to be shown both ways of the ring at the walk, trot, and canter; may be asked to extend the trot. The order to reverse is executed by turning away from the rail. Horses may be asked to back in the line-up. Horses shown Hunter Seat are judged on suitability to purpose, head carriage, gait, and control; bit contact should be maintained. Horses shown Saddle Seat are judged on performance and ability to give a good pleasure ride with emphasis on style, manners, and gait; bit contact must be maintained.

### 4-H/WAHSET/OHSET Western Equitation (No WSH)

Exhibitors enter the arena at the walk and will perform both ways of the ring at the walk, jog, and lope. The order to reverse is executed by turning away from the rail. Exhibitors will be required to back their horses. Individual tests or patterns may be asked for and may consist of but are not limited to the following: extended jog or lope, forehand or haunch turns, riding without stirrups, figure eights or serpentines at any gait.

### 4-H/WAHSET/OHSET Western Pleasure (No WSH or NWZ Pts.)

Horses to be shown both ways of the ring at the walk, jog, and lope; may be asked to extend the jog. The order to reverse is executed by turning away from the rail. Horses may be asked to back in the line-up. Judged on manners, performance, and suitability to give a good pleasure ride.

### **ALL OTHER BREEDS**

Open to registered and unregistered horses and ponies. An unregistered horse or pony has no papers of any type. A horse with multiple registrations entered in a regularly scheduled Breed class may enter an All Other Breeds class for WSH points for a different Breed that is not offered at the show. A horse with Half-Breed papers for one Breed may not also show as "unregistered" for any other Breed. No horse may enter the All Other Breed class if the Breed class for which they were eligible has filled and been judged.

### All Other Breeds English Pleasure

Tack and attire shall be suitable to horse's type; martingale prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait, and canter. Judged on manners and performance 60%; quality and conformation 30%; suitability of horse to rider 10%.

### All Other Breeds Western Pleasure

Horses are to be shown at a flat footed four-beat walk; free moving easy riding two-beat jog, and three-beat lope both ways of the ring on a reasonably loose rein without undue restraint. Extended gaits may be called for by the Judge. Entries shall be penalized for being on the wrong lead. Special emphasis shall be placed on the walk. Horses may be asked to back at the Judge's discretion. All horses chosen for a workout must be worked both ways of the ring at any gait requested by the Judge. To be judged on performance 60%; conformation 30%; and appointments 10%.

### **ARABIAN & HALF-ARABIAN HORSE DIVISION**

Arabian entries must be registered with AHA and/or CAHR; Half-Arabian entries must be registered with AHA in the Half-Arabian and/or Anglo-Arabian Registry, or eligible to register and registration applied for. Horses must be entered under full name and registry number. English Pleasure classes are open to English, Country English and Hunter Pleasure horses, shown under tack and appointments suitable to type, per USE. Purebred Arabian - open to mares, geldings and stallions. Half-Arabian - open to mares and geldings only.

### Arabian/Half-Arabian English Pleasure

To be shown at a walk, normal trot, strong trot, canter, and hand gallop. Judged on manners, performance, attitude, quality, and conformation.

### Arabian/Half-Arabian Western Pleasure

To be shown at a walk, jog, lope and hand gallop. Extreme speed to be penalized. Judged on manners, performance, attitude, quality, and conformation.

### **ENGLISH PLEASURE DIVISION**

Classes are open to Horses and Ponies and may be shown by riders of any age. Junior Exhibitors are restricted to mares and geldings. No cross entry is permitted between Exhibitor age groups. Unless specified otherwise, acceptable bits for classes in this division include: regulation snaffles (inc. twisted wire), curbs, pelhams (inc. kimberwicks), and full bridles. Prohibited bits include:

gag bits, mechanical hackamores, and flat polo mouthpieces; use of prohibited bits will result in disqualification. Judges may penalize for non-conventional types of bits and nosebands. Martingales are prohibited. Different breeds showing in Open classes are to be shown according to their breed type. Unless specifically prohibited by class rule, Dressage attire and tack may be used in English Pleasure classes.

### **Advanced English Pleasure**

To be shown at a walk, trot and canter. A minimum of three (3) or more additional tests must be included. Some examples of tests, but not limited to, may include the following: extension of gait, collection of gait, forehand/haunch turn, back, change direction, sidepass, loose rein, shoulders in/out, leg yield, 10 meter circle, counter canter and/or perform any other tests indicative of a highly trained pleasure horse. If a reverse at the canter is called for, exhibitors shall reverse and proceed on the lead specified by the judge. All horses must be allowed to attempt all requested tests. Horses should be agile, athletic, supple, prompt, and willing, and show impulsion with calmness and good manners. Judged on performance and manners. \*No dropping of irons shall be permitted.

### **English Pleasure, Colored Horses**

Open to Albino, Appaloosa, Buckskin, Dun, Grulla, Paint, Palomino, and Pinto horses who are not shown in Non-Color Class English. Horses must show a recognizable coat and/or color pattern from a distance. Tack and attire shall be suitable to horse's type; martingale prohibited. To be shown at a walk, trot/intermediate gait, and canter, both ways of the ring. Light contact with the horse's mouth shall be maintained. Judged 40% on colorful qualities, 40% on performance, way of going and manners, and 20% on conformation.

### English Pleasure, Green Horse 1st & 2nd Yr.

Eligibility requirements are based on a horse's prior participation in English classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year. For horses in their first or second year of showing under English tack in USE/Equine Canada/WSH and/or Breed Association recognized shows. Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown at a walk, trot/intermediate gait, and canter both ways of the arena. No extension of gaits shall be called for. Shall not be asked to gallop or reverse at the canter. May be asked to back. Judged 60% on performance, 30% on conformation, and 10% on appointments. Cross entry is permitted into walk/trot and three (3) gait classes.

### English Pleasure, Green Horse 1st & 2nd Yr., W/T

Eligibility requirements are based on a horse's prior participation in any type English or Hunter classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year with any owner. For horses in their first or second year of showing under English tack in USE/Equine Canada/WSH and/or Breed Association recognized shows. Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait both ways of the arena. No extension of gaits shall be called for. May be asked to back. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. May cross enter walk, trot, and canter classes.

### English Pleasure, Green Rider 1st & 2nd Yr. (No NEZ pts)

Eligibility requirements are based on a riders prior participation in English classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year. For riders in their first or second year of showing under English tack in USE/Equine Canada/WSH and/or Breed Association recognized shows. Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown at a walk, trot/intermediate gait, and canter both ways of the arena. No extension of gaits shall be called for. Shall not be asked to gallop or reverse at the canter. May be asked to back. Judged 60% on performance, 30% on conformation, and 10% on appointments. Restriction is on the rider. To be shown at walk, trot/intermediate gait and canter both ways of the arena. No extension of gaits shall be called for. Cross entry is permitted into walk/trot and three (3) gait classes.

### English Pleasure, Green Rider 1st & 2nd Yr., W/T (No NEZ Pts)

Eligibility requirements are based on the riders prior participation in English classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year. For riders in their first or second year of showing under English tack in USE/Equine Canada/WSH and/or Breed Association recognized shows. Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown at a walk, trot/intermediate gait, and canter both ways of the arena. No extension of gaits shall be called for. Shall not be asked to gallop or reverse at the canter. May be asked to back. Judged 60% on performance, 30% on conformation, and 10% on appointments. Walk/Trot is restriction on the rider. To be shown at walk and trot only. Cross entry is permitted into walk/trot and three (3) gait classes.

### English Pleasure Horse, Hunter Type

Not to jump. To be shown at a walk, trot, and canter; martingale prohibited. Judged on manners, performance, quality, and suitability of horse to rider. Light contact is recommended.

### English Pleasure, Other than Hunter Type, All Ages

No forward seat saddles, dressage saddle or attire and/or hunt attire allowed; martingales prohibited. Roached manes and/or set or gingered tails are prohibited. To carry a pleasure foot in accordance with Breed specifications. To be shown according to Breed type at a flat walk, trot/intermediate gait, and easy canter. Light contact must be maintained. To stand quietly and back readily. Judged 80% on manners and performance, with emphasis on a pleasurable ride, and 20% on conformation. No cross entry between age groups at the same show.

### English Pleasure

Tack and attire shall be suitable to horse's type; martingale prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait, and canter. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%.

English Pleasure, Jr. Ex, 13 & Under

English Pleasure, Sr. Ex. 19-49

English Pleasure, Sr. Ex. 50 and Over

### English Pleasure, W/T (No WSH/NEZ Pts)

Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait. No extension of gaits shall be called for. May be asked to back. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. The same horse/rider combination may cross enter to three (3) gait classes.

English Pleasure, Jr. Ex. 13 & Under W/T (No WSH/NEZ Pts)

English Pleasure, Jr. Ex. 14-18 W/T (No WSH/NEZ Pts)

English Pleasure, Sr. Ex. 19 & Over W/T (No WSH/NEZ Pts)

### English Pleasure, Limit Horse

Open to horses who have not won six firsts in English Pleasure. Tack and attire shall be suitable to horse's type, martingale prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait, and canter. Judged on manners and performance 60%, quality and conformation 30% and suitability of horse to rider 10%. Cross entry is permitted into walk/trot and three (3) gait classes.

### English Pleasure, Limit Horse W/T

Open to horses who have not won six firsts in English Pleasure. Tack and attire shall be suitable to horse's type, martingale prohibited. To be shown both ways of the ring at a walk and trot/intermediate gait. Judged on manners and performance 60%, quality and conformation 30% and suitability of horse to rider 10%. Cross entry is permitted into walk/trot and three (3) gait classes.

### English Pleasure, Limit Rider (No NEZ Pts)

Open to riders who have not won six firsts in English Pleasure. Tack and attire shall be suitable to horse's type, martingale prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait, and canter. Judged on manners and performance 60%, quality and conformation 30% and suitability of horse to rider 10%. Cross entry is permitted into walk/trot and three (3) gait classes.

### English Pleasure, Limit Rider W/T (No NEZ Pts)

Open to riders who have not won six firsts in English Pleasure. Tack and attire shall be suitable to horse's type, martingale prohibited. To be shown both ways of the ring at a walk and trot/intermediate gait. Judged on manners and performance 60%, quality and conformation 30% and suitability of horse to rider 10%. Cross entry is permitted into walk/trot and three (3) gait classes.

### **English Pleasure, Non-Colored Horses**

Open to horses who are not shown in Color Class English. Martingale prohibited. To be shown according to Breed type at a flat-footed walk, trot/intermediate gait and easy canter. Light contact must be maintained. Judged 80% on manners and performance, with emphasis on a pleasurable ride, and 20% on conformation.

### English Pleasure, Open

Tack and attire shall be suitable to horse's type; martingale prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait, and canter. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. Points from English Pleasure JR horse five (5) & under and SR horse six (6) and over to count.

### English Pleasure Open, W/T (No WSH/NEZ Pts)

Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait. No extension of gaits shall be called for. May be asked to back. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. The same horse/rider combination may cross enter to three (3) gait classes.

### English Pleasure Sr. Am., W/T (No WSH/NEZ Pts)

Horses of any age may be shown in standard English tack. Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown both ways of the ring at a walk, trot/intermediate gait. No extension of gaits shall be called for. May be asked to back. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. The same horse/rider combination may cross enter to three (3) gait classes.

### **EQUITATION DIVISION**

SHOWMANSHIP IN HAND, ENGLISH OR WESTERN: Exhibitors will be asked to demonstrate their ability to lead, turn, set-up and move their animals as the Judge directs. The Judge may ask exhibitors to perform other tests. Judges' techniques and procedures will vary. The following principles always apply: individual tests must be performed with Official(s) involved in the test in the same relative position to each exhibitor. The exhibitor shall not stand directly in front of the horse. The exhibitor shall always lead, back, or move the horse from the left (near) side, unless otherwise specified in the pattern. All turns of 180 degrees or more shall be to the right, with the exhibitor walking to the right around the horse. Forehand turns of any degree to either direction are permissible. Quartering system is mandatory. Judges must penalize any exhibitor that does not demonstrate the quartering system. Horses may be shown according to breed type. Shows may combine English and Western Showmanship. If separated, both must be offered. Fitting, grooming, and neatness of handler are 40% of the judging criteria.

### Bareback Horsemanship, Eng/West, Jr. Ex./Sr. Am. (No NEZ Pts)

Riders to wear appropriate English or Western riding apparel. Horses are to be worked both ways of the ring at a walk, jog/trot/intermediate gait, and canter/lope, and shall always be on the correct lead. Riders may be asked for any additional tests the Judge may deem necessary. Riders shall not be asked to dismount and mount. Judged on hands, seat and suitability of horse to rider. Options:

- a. Rail work showing three gaits both directions and a back either on the rail or in line up.
- b. Pattern work only, with no rail work required.
- c. A combination of pattern & rail work.

### LEADLINE, WALK/WHOA, WALK/TROT 10 & UNDER CLASSES

All 10 & Under exhibitors, riding (any seat) are required to wear properly fastened protective headgear which meets or exceeds ASTM/SEI standards when mounted.

LEADLINE EQUITATION: No cross entry to any other class except Showmanship 10 Yrs. & Under is permitted at the same show where the rider is participating in the Leadline class.

WALK/TROT 10 & UNDER: No cross entry into any class that canters or lopes at the same show rider is participating in the Walk/Trot 10 & Under classes. Cross entry to Showmanship and any Walk/Jog or Walk/Trot class rider is eligible to enter is permitted.

### Leadline Equitation, Eng/West. Riders 6 & Under

Recommend ribbons to eight (8) places; participation ribbons to all. Saddle Seat, Hunter Seat, or Western Seat tack and appointments. Hooded stirrups are permitted. Riders to wear an ASTM/SEI approved helmet properly fitted with harness in place at all times when mounted. Spurs are prohibited. To be led from the ground by a Senior (19 & over). Horse to be led by lead shank attached to a halter. To be shown both ways of the ring at a walk only. Rider may not be tied in the saddle in any way. If feet are not in the stirrups, the exhibitor may be penalized. Judged on seat, hands, and general horsemanship. Suitability of mount to rider to be considered. No cross entry to any other ridden/driven class in the show, except Leadline Trail. Leadline riders may enter 10 & under showmanship. The lead person should conform to proper English or Western attire and be consistent with the rider. (Note: Cross entry restriction is on the rider; it does not apply to the horse.)

### Walk/Whoa Equitation, Eng/West, Riders 8 & Under

Saddle Seat, Hunter, or Western Seat tack and appointments. Hooded stirrups are permitted. Riders to wear an ASTM/SEI approved helmet properly fitted with harness in place at all times when mounted. Spurs are prohibited. To be shown both ways of the ring at a walk only. Riders to be asked to halt their mounts on the rail each way of the ring, and back a few steps in the line-up. Judged on seat, hands, and general horsemanship. Suitability of mount to rider to be considered. No cross entry to any other ridden/driven class in the show except 10 & Under Showmanship. (Note: Cross entry restriction is on the rider and does not apply to the horse.

### Walk/Trot Equitation, Eng/West, Riders 10 & Under

Hunter Seat, Saddle Seat or *Western* Seat (chaps optional), Hooded stirrups permitted. To be shown both ways of the ring at a walk and jog/trot/intermediate gait. Not to canter/lope. Judged on seat, hands, and general horsemanship. Suitability of mount to rider to be considered. Rider may not cross enter to any lope or canter classes in the same show, except W/T Pleasure, Limit W/T or W/J Equitation or Pleasure and W/T Trail Classes. (Note: Cross entry restriction is on the rider; it does not apply to the horse.)

### Walk/Trot Pleasure, Eng/West, Riders 10 & Under

Hunter Seat, Saddle Seat or Western Seat (chaps optional), Hooded stirrups permitted. To be shown both ways of the ring at a walk and jog/trot/intermediate gait. Not to canter/lope. Judged on seat, hands, and general horsemanship. Suitability of mount to rider to be considered. Rider may not cross enter to any lope or canter classes in the same show, except W/T Pleasure, Limit W/T or W/J Equitation or Pleasure and W/T Trail Classes. (Note: Cross entry restriction is on the rider; it does not apply to the horse.)

### **MISCELLANEOUS CLASSES**

### Jack Benny Pleasure, Eng/West, Sr AM, 39 & Over - Amateur Card Required

Same horse/rider combination for High Score Awards. For tack and appointments see Hunter Seat, Saddle Seat, or Western Equitation Section of this rule book. <u>To enter the ring at a walk</u>. To be shown according to Breed type at a walk, trot/jog/intermediate gait, and canter/lope, both ways of the ring. Judged on manners, performance, and suitability of horse to rider.

### PAINT HORSE DIVISION

Entries must be APHA registered and be entered under full name and registry number. Solid Paint-breed Paints are not eligible. Paint Horse Hunter Under Saddle (BPH)

Not to jump. To be shown at a walk, trot, and canter both ways of the ring. Horses may change gaits at the flat-footed walk or trot at the Judge's discretion. Light contact with horse's mouth recommended. Horses should back easily and stand quietly. At Judge's option, all or just top eight (8) horses may be required to hand gallop, one or both ways of the ring. Never more than eight (8) horses to hand gallop at one time. At the hand gallop, Judge may ask the group to halt and stand quietly on a free rein (loosened rein).

### Paint Horse Western Pleasure

Horses are to be shown at a walk, jog and lope with forward motion on a reasonably loose rein with-out undue restraint. It is mandatory that a moderate extension of the jog be asked for in at least one direction. Horses must work both ways of the ring at all three gaits to demonstrate their ability with the different leads. A horse will not be penalized for passing. A judge may back only the finalist. Horses are to reverse to the inside, away from the rail. Horses may be required to reverse at a walk or jog or may be required to go from any gait to any other gait at the discretion of the judge. Forward motion must be maintained. No contestant will be asked to reverse at the lope.

### **QUARTER HORSE DIVISION**

Entries must be AQHA registered and be entered under full name and registry or appendix number.

### **Quarter Horse Hunter Under Saddle**

Not to jump. Horses to be shown under saddle at a walk, trot and canter both ways of the ring. Horses should back easily and stand quietly. Horses may change gaits at the flat footed walk or trot at the Judge's discretion. Light contact with the horse's mouth is recommended. At the option of the Judge, all or just the top 12 may be required to hand gallop one or both ways of the ring. Never more than 12 to hand gallop at one time. At the hand gallop, Judge may ask group to halt and stand quietly on a free (loosened rein). Judged on performance, condition and conformation of the horse, however a minimum of 20% of the judging shall be based on condition and conformation. Maximum credit shall be given to the flowing, balanced, willing horse.

### **Quarter Horse Western Pleasure**

To be shown at a walk, jog and lope both ways of the ring on a reasonably loose rein, or light contact, without undue restraint. Horses must lope with forward motion. Horses must back easily and stand quietly. It is mandatory that a moderate extension of the jog be asked for in at least one direction of the ring (except youth 13 & under classes, where it is optional). Judged on performance and conformation of the horse at the discretion of the Judge; however, a minimum of 20% of the judging shall be based on condition and conformation. Maximum credit shall be given to the flowing, balanced, and willing horse.

### **RANCH HORSE DIVISION**

### Ranch Conformation

The purpose of ranch conformation is to present a well-mannered horse which reflects a positive combination of balance, structural correctness, and movement with appropriate breed and sex characteristics and adequate muscling. The ideal Ranch conformation horse should have a natural ranch horse appearance from head to tail. Horses are to be shown in a good working halter: rope, braided, nylon or plain leather. Horses may be shown in a leather lead shank with an attached chain either under or over the nose. Banding, braiding, hoof polish, tail extensions and trimming of ears are discouraged but will not be penalized. Sponsor Tina Trussell

### Ranch Rail, Jr. Sr. Ex. W/J (No WSH/NEZ Pts)

The purpose of Ranch Riding horse should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse riding outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward and working speed while under control by the rider. Light contact should be rewarded, and horse shall not be shown on a full drape of reins. Allow posting and holding the saddle horn. The horses head position should be elevated and above the level at all gaits. The overall manners and responsiveness of the horse while performing the maneuver requirements, and the horse's quality of movement are the primary considerations. Exhibitors will be asked to walk, extend the walk, jog, extend the jog, stop from any gait, back, and turn of 180 degrees. **Cross entry is permitted into walk/jog and 3 gait classes.** 

### Ranch Rail Open

Horses competing in Ranch Rail class should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse riding outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward and working speed while under control by the rider. Light contact should be rewarded and horse shall not be shown on a full drape of reins. Allow posting and holding the saddle horn. The horses head position should

be elevated and above the level at all gaits. The overall manners and responsiveness of the horse while performing the maneuver requirements, and the horse's quality of movement are the primary considerations. The class will be worked both directions of the arena. Exhibitors will be asked to walk, extend the walk, jog, extend the jog, lope, extend the lope, stop from any gait, back, side pass to and from the rail, and turn of 180 degrees or greater. Any class size greater than 8 may be worked in lots at show management or judge's discretion depending on arena capacity and safety.

Ranch Rail, Jr Ex 18 & Under Ranch Rail, Sr Ex 19 & Over

### Ranch Riding, Open

The purpose of Ranch Riding horse should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse riding outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward and working speed while under control by the rider. Light contact should be rewarded, and horse shall not be shown on a full drape of reins. Allow posting and holding the saddle horn. The horses head position should be elevated and above the level at all gaits. The overall manners and responsiveness of the horse while performing the maneuver requirements, and the horse's quality of movement are the primary considerations.

Ranch Riding, Jr Ex 18 & Under Ranch Riding, Sr Ex 19 & Over

### **WESTERN DIVISION**

Classes are open to horses and ponies and may be shown by riders of any age. Junior Exhibitors are restricted to mares and geldings. No cross entry is permitted between exhibitor age groups. Appropriate Western attire is required which includes western hat or ASTM/SEI helmet, long sleeve shirt with collar (band, standup, tuxedo, etc.), pants (slacks, trousers, jeans), and riding boots with a heel; chaps and spurs (with or without rowels) are optional. Refer to the USE Western Division for tack specifications.

### **Advanced Western Pleasure**

To be shown at a walk, jog and lope. A minimum of three (3) or more additional tests must be included. Some examples of tests, but not limited to, may include the following: extension of gait, collection of gait, forehand/haunch turn, back, change direction, sidepass, loose rein, shoulders in/out, leg yield, 10 meter circle, counter lead at the lope and/or perform any other tests indicative of a highly trained pleasure horse. If a reverse at the lope is called for, exhibitors shall reverse and proceed on the lead specified by the judge. All horses must be allowed to attempt all requested tests. Horses should be agile, athletic, supple, prompt and willing, and show impulsion with calmness and good manners. Judged on performance and manners. \*No dropping of stirrups shall be permitted.

### Western Pleasure, Colored Horses

Open to Albinos, Appaloosas, Buckskins, Duns, Grullas, Paints, Palominos and Pintos, who are not shown in Non-Color Western. Horses must show a recognizable coat and/or color pattern from a\_distance. To be shown according to Breed type at a walk, jog/intermediate gait, and lope, both ways of the ring on a reasonably loose rein, without undue restraint. Special emphasis on the walk. Judged 40% on colorful qualities, 40% performance and manners, and 20% on conformation.

### Western Pleasure, Green Horse 1st & 2nd Yr.

Eligibility requirements are based on a horse's prior participation in any type of Western Pleasure classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year with any owner. For horses in their first or second year of showing under Western tack in USE/Equine Canada/WSH and/or Breed Association recognized shows except, horses of any age may be shown in a standard Western bit (with one hand only) or in a ring snaffle or standard rawhide hackamore (two hands permitted). Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown both ways of the ring at a walk, jog/intermediate gait and lope. No extension of gaits shall be called for. May be asked to back. Judged on manners and performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. May cross enter to walk, jog, lope classes.

### Western Pleasure, Green Horse 1st & 2nd Yr., W/J

Eligibility requirements are based on participation in Western classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year. For horses in their first or second year of showing under Western tack in USE/Equine Canada/WSH and/or Breed Association recognized shows. except, horses of any age may be shown in a standard Western bit (with one hand only) or in a ring snaffle or standard rawhide hackamore (two hands permitted). Tack and attire shall be suitable to horse's type; martingales and training equipment *are* prohibited. To be shown at a walk, and jog/intermediate gait, both ways of the arena. No extension of gaits shall be called for. May be asked to back. Judged 60% on performance, 30% on conformation, and 10% on appointments. Cross entry is permitted into walk/trot and 3 gait classes.

### Western Pleasure, Green Rider 1st & 2nd Yr. (No NEZ Pts)

Eligibility requirements are based on a rider's prior participation in any type of Western Pleasure classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year. For riders in their first or second year of showing under Western tack in USE/Equine Canada/WSH and/or Breed Association recognized shows except, horses of any age may be shown in a standard Western bit (with one hand only) or in a ring snaffle or standard rawhide hackamore (two hands permitted). Tack and attire shall be suitable to horse's type; martingales and training equipment prohibited. To be shown both ways of the ring at a walk, jog/intermediate gait and lope both ways of the arena. No extension of gaits shall be called for. May be asked to back. Judged on manners and

performance 60%, quality and conformation 30%, and suitability of horse to rider 10%. May cross enter to walk, jog classes. Cross entry is permitted into walk/jog and three (3) gaited classes.

### Western Pleasure, Green Rider 1st & 2nd Yr. W/J

Eligibility requirements are based on a rider's prior participation in any type of Western Pleasure classes at USE/Equine Canada/WSH and/or Breed recognized shows prior to the current year. 
The undersigned, as a Participant/Spectator/Visitor/Horse Owner/Contractor/Volunteer (collectively "Participant"), on his/her own behalf and, if applicable, as the Parent/Legal Guardian of a minor Participant, for good and valuable consideration, agrees to the terms and conditions of this Release, Waiver, Hold Harmless, Defend, and Indemnification Agreement ("Release").

- Assumption of Risk and Walver: Participant understands and accepts the risks of engaging in Equine Activities, while mounted or unmounted, as well as merely being near a horse, pony, mule, donkey, or hinny (collectively "equine"), include, but are in no way limited to, faulty equipment or tack that cause injury or death, Released Parties' failure to make a reasonable effort to determine the ability of Participant to engage safely in an equine activity or to safely manage the particular equine provided based on Participant's representations of his or her ability, Released Parties' failure to conspicuously post warning signs of a dangerous inconspicuous condition on the real property, as well as: (1) the propensity of an equine to behave in a way that may result in injury or death to a person on or near it (ex.: jump, run, kick, buck, bolt, spin, rear up, strike, bite, stumble, fall, etc.); (2) the unpredictability of an equine's reaction to a sound (ex.: doors opening and dosing, snow and ice falling, rain, wind, thunder, voices, music, guns, planes, cars, trucks, etc.), movement, or unfamiliar object (ex.: machinery, equipment, obstacles, buggies, carts, barrels, ground poles, cones, flowers, flags, golf carts, mini-bikes, whips, bats, construction material, etc.), person or animal (ex. leashed or unleashed dogs, ducks, wildlife, equines, etc.); (3) a collision with an object or another animal (ex.: mounted equine, loose equine, etc.); (4) the potential for a person participating in an equine activity to act in a negligent manner, to fail to control the equine or to not act within his or her ability; and (5) natural hazards, including surface and subsurface conditions (ex.: ground holes, uneven terrain, slippery or deep footing, etc.). Participant agrees that engaging in Equine Activities under this Release includes, but is in no way limited to, those defined in the Washington Equine Activity Liability Statute, WA ST 4.24.530 et seq., as well as riding another's equine, petting, guiding, leading, mounting, feeding, watching, and otherwise interacting with or merely being in the vicinity of equines (collectively "Equine Activities"). Participant understands the injuries, death, loss, and damage that may result from the inherent risks of engaging in Equine Activities or just being near equines, that equines are powerful and have the potential to be dangerous, even without warning, and that the risks listed in this Release is just a sampling and Participant is not relying on Released Parties (defined below) to list all possible equine-related risks. Participant understands that Washington State Horseman Horse Show Division ("WSH HSD") requires the wearing of an ASTM/SEI-certified equestrian helmet ("Helmet") consistent with the Washington State Horsemen rules. Participant understands and agrees that failing to wear a Helmet while engaged in Equine Activities increases the risk of serious injury and/or death, Participant is not relying on Released Parties to provide a Helmet, check a Helmet or its harness strap for proper fitting, or monitor the wearing of a Helmet at any time now or in the future. Participant understands and agrees that Participant has other riding associations and facilities to choose from, he/she has inspected the facility for the Equine Activities and is satisfied that all are reasonable and safe for Participant's intended use, he/she is voluntarily engaging in Equine Activities, he/she is directly and intentionally engaging in and assuming the risks of Equine Activities, and he/she agrees to at all times to be responsible for his/her personal safety. Participant agrees to purchase and maintain his/her health and liability insurance, remain responsible for his/her medical expenses, and waives his/her right to any claims arising from his/her participation in or observation of any Equine Activities, being near equines, or merely being present on real property owned, leased, rented, borrowed, visited, or otherwise occupied or utilized by Released Parties. "Released Parties" herein includes the Washington State Horseman Horse Show Division, its members, officers, directors, employees, contractors, and their respective family members, heirs, agents, trustees, beneficiaries, employees, working students, volunteers, independent contractors, clinicians, guests, visitors, invitees, partners, members, managers, officers, directors, owners, lessors, lessees, licensees, and others acting on their behalf.
- 2. Release, Hold Harmless, Defend, Indemnify: Participant agrees to release, hold harmless, defend, and indemnify Released Parties for any illness, injury, death, damage, or other loss (collectively "Loss") incurred by Participant or to Participant's property and/or equine, even if such Loss is caused in whole or in part by negligence or other fault of Participant or Released Parties (except gross negligence, or reckless or willful and wanton conduct). This Release shall not expire and shall remain in full force and effect in perpetuity.
- 3. Governing Law, Jurisdiction, Time/Liability Limitation, Attorneys' Fees, Jury Waiver: This Release shall be construed and enforced in accordance with the laws of the State of Washington. All disputes relating to the interpretation and enforcement of this Release shall be resolved by the state court in Pierce County, Washington. Participant agrees that any and all claims for Loss by Participant against Released Parties must be brought within one (1) year of the date accrued and any surviving claim for personal property Loss is limited to two hundred and fifty dollars (\$250). Participant agrees to reimburse Released Parties for any and all attorneys' fees and costs incurred by Released Parties in enforcing the terms of this Release and/or in defending or prosecuting any claims or causes of action involving or relating to Participant. Participant agrees to waive trial by jury in any action with Released Parties.
- 4. Severability, Modification: If any provision of this Release is deemed invalid or unenforceable, the remaining provisions shall be valid and enforceable to the fullest extent of the law. The Release can only be modified if signed by Participant and WSH HSD Director.
- 5.
