2024 Proposed 2025 WSH Rulebook changes

RULE 3 - RECOGNIZED HORSE SHOWS

PG 15 Section 1. WSH RECOGNIZED HORSE SHOWS

3. Washington State Horsemen Divisions and/or Zones may approve but shall not sponsor any activities in which horses and/or exhibitors participate for points towards year end standings. This does not prohibit the four major divisions from holding a state finals or championship shows.

a. Zone Benefit Shows must be sponsored by an organization or club and must show proof of liability. Finances to be handled by the sponsoring organization or club.

CHANGE TO READ:

ADDITIONAL PARAGRAPH FOR WSH RECOGNIZED HORSE SHOWS

Washington State Horsemen Divisions and/or Zones may approve but shall not sponsor any activities in which horses and/or exhibitors participate for points towards year end standings. This does not prohibit the four major divisions from holding a state finals or championship shows.

Rule 1 – THE HORSE SHOW DIVISION

PG 9 - Section 4. COMMITTEES

Points Keeper

b. Points keeper shall tabulate points. Points from each show must be tabulated within 15 days of results receipt. If a show takes place prior to May those shows shall be tabulated in the month of May.

PG 9 Section 5. HORSE SHOW DIRECTOR

K. Present a budget to the Budget Committee annually and submit a Quarterly financial report

This sentence needs to be moved from Horse Show Director to the Finance Chair and become para F for Rule 1, Section 4, Committees, Finance Chair. And renumber the rest.

(Erin Wieldraayer) Joy B moved to accept/ George C 2nd. **Approved.**

We went to the board in Jan 2023 to approve the change. When the board approves a rule change out of the normal cycle of convention meetings/rule changes, it needs to be approved at the next annual meeting at convention. We missed adding it to the agenda rule changes at the 2023 annual meeting. (Erin Wieldraayer)

PG 10 Section 7. RULE CHANGES

1. Rule book changes or clarifications must be presented to the Horse Show Director by August 10th with a payment of \$5.00 (HS Finance and Rule book Committee exempt) to be considered for the current year at Convention. No rule changes may be made between Conventions.

Rule 2 – SHOW DATES

PG 12 Section 1 GENERAL INFORMATION

3. Requests for show date approval must be submitted in writing to the Horse Show Director prior to December 1. Prior show dates will be reserved until December 1.

Prior show dates will be reserved until December 1. ***If applying after December 1, application must be received 90 days prior to the show date.*** (Erin Wieldraayer) Joy B moved to accept/ Pam K 2nd.

PG 25 - Rule 4 Section 4: Changes in Prize List:

Add Para C: Should the show management change the start time of the horse show, it must be done prior to 48 hours before the start of the show and every pre-entered exhibitor must be notified of the change of start time. This only applies if the show start time is moving earlier. It is encouraged to have verification of notification from the exhibitors as well as using social media to advertise the change.

After much discussion, Sylvia G moved to amend the proposal for Rule 4, Section 3, add paragraph 1t (Pg 25):

“Show committee may alter the start time of the show +/- one (1) hour. It is the exhibitor's responsibility to maintain contact with the show committee for updated information.” George C 2nd. Approved

George moved to accept the rule change, as amended/ Tina T 2nd. **Approved.**

PG 14 - Section 7. CANCELLATIONS

3. Any show Competition that is cancelled by events other than an Act of God, must notify the Horse Show Chairperson, in writing, no later than fourteen (14) days before the Competition date. Failure to do so will constitute the denial of any further show dates being approved at the Director's discretion, and a fine levied by the Horse Show Director of \$100.00. They must also send written notice by registered mail to the Horse Show Director and contracted Officials. Competition must also notify all pre-entered exhibitors by telephone or registered mail.

Change to Read:

3. Any show Competition that is **cancel**ed by events other than an Act of God, must notify the Horse Show Chairperson, in writing, no later than fourteen (14) days before the Competition date. Failure to do so will constitute the denial of any further show dates being approved at the Director's discretion, and a fine levied by the Horse Show Director of \$100.00. They must also send written notice by e-mail to the Horse Show Director and contracted Officials. Competition must also notify all pre-entered exhibitors by telephone, registered mail, ***or e-mail. It is encouraged to have verification of notification of receipt of cancellation notice from the exhibitors.***

Joy B moved to accept/ Pam K 2nd. **Approved.**

Rule 3 – RECOGNIZED HORSE SHOWS

Section 1 WSH Recognized Horse Shows

PG 15 – 16

Currently Reads:

7a: The Show Manager is to be the person in charge of the WSH approved show, but may not serve as show secretary, ring steward or serve in any other capacity which might interfere with their effectiveness as manager. The Show Manager must be at least 18 years of age. The manager shall have authority to enforce all rules referring to the show and he/she may excuse any horse or exhibitor from the show or contest prior to or during the judging. He/she shall be present on the show grounds for the duration of the show. In the event an emergency arises and the show manager is unable to fulfill his/her duties, an acting manager should be appointed. The show manager must submit a written explanation to WSH for his/her absence. The acting show manager must also remain on the show grounds for the duration of the show and must meet the requirements as set forth above.

Change to Read:

7. a The Show Manager is to be the person in charge of the WSH approved show, but may not serve as show secretary, ring steward or serve in any other capacity which might interfere with their effectiveness as manager. The Show Manager must be at least 18 years of age. The manager shall have authority to enforce all rules referring to the show and he/she may excuse any horse or exhibitor from the show or contest prior to or during the judging. He/she shall be present on the show grounds for the duration of the show. In the event an emergency arises and the show manager is unable to fulfill his/her duties, an acting manager should be appointed. The show manager must submit a written explanation to WSH for his/her absence. The acting show manager must also remain on the show grounds for the duration of the show and must meet the requirements as set forth above. ***Should the Show Manager choose to exhibit a horse in the horse show they are managing, then the Show Manager cannot contact Licensed Officials, negotiate or adjudicate any contracts for the horse show.*** (Erin Wieldraayer) George C moved to accept/ Tina T 2nd.

After discussion, Heather moved to amend the new sentence to: ***“Should the Show Manager choose to exhibit a horse in the horse show they are managing, then the show Manager cannot contact, negotiate or adjudicate any contracts for the horse show Licensed Officials.”*** Joy B 2nd. Amendment Approved and rule change **APPROVED** as amended.

Rule 3 – Recognized Horse Shows

Section 1: PG 17

Currently Reads:

14. Each show must assign a person as the Trail Course Designer. It cannot be a Judge or Steward of that show. The trail course designer is responsible for the course design and description, supplying a pattern of course/s to the Show, setting up the trail course, fixing & maintaining the course between exhibitors and classes and tear down of the trail course. The judge/s, steward and course designer must walk the course/s with exhibitors prior to the start of the trail class(es).

Change to Read:

14. Each show must assign a person as the Trail Course Designer. It cannot be a Judge or Steward of that show. ***The judge or steward of the show may change the course to fit the abilities of the riders and equines, time constraints and or for safety reasons.*** The trail course designer is responsible for the course design and description, supplying a pattern of course/s to the Show, setting up the trail course, fixing & maintaining the course between exhibitors and classes and tear down of the trail course. The judge/s, steward and course designer must walk the course/s with exhibitors prior to the start of the trail class (es). (Erin Wieldraayer) Dan Moriarty moved to accept/ Tina T 2nd. **Defeated**

Currently Reads:

PG 17 - 15. If there is a discrepancy between the written and drawn pattern/s in ANY class, the written pattern shall take precedence.

Change to Read:

15. If there is a discrepancy between the written and drawn pattern/s in ANY class, the written pattern shall take precedence. **All exhibitors must be notified, made aware, of any changes to the pattern prior to their class starting.** (Erin Wieldraayer) George C moved to accept/ Tina T 2nd.

After discussion, Heather F moved to change the new sentence to: **Exhibitors shall be made aware of any changes to the pattern prior to starting the class.** George C 2nd. Amendment approved.

Motion **Approved**, as amended.

Currently Reads:

PG 17 - 17. For all classes for which courses/patterns/tests are required or maybe asked for, i.e. Equitation Division, Working Horses, Trail, Western Riding: All courses/tests/patterns must be posted at least one (1) hour before the scheduled start time of the class, but not prior to one (1) week before the start date of the show. NRHA Reining and AQHA Ranch Riding standardized pattern numbers shall be printed in the prize list.

Change to Read:

17. For all classes for which courses/patterns/tests are required or maybe asked for, i.e. Equitation Division, Working Horses, Trail, Western Riding: All courses/tests/patterns must be posted at least one (1) hour before the scheduled start time of the class, but not prior to one (1) week before the start date of the show. NRHA Reining and AQHA Ranch Riding standardized pattern numbers shall be printed in the prize list. **Exception being an A System show hosting WSH Classes, there is no time limit on when patterns can be posted besides a minimum of 1 hour before the class.** (Erin Wieldraayer) George C moved to accept/ Tina T 2nd. **Approved.**

PG 17 - Section 2 Amateurs and Professionals

1. WSH Horse Shows accept ApHC, ABRA, AQHA, AMHA, APHA, PtHA, NRHA, WSH, USE Amateur Cards/Non-Pro Card.

Change to Read:

1. WSH Horse Shows accept ApHC, ABRA, AQHA, AMHA, APHA, PtHA, NRHA, WSH, Amateur Cards/Non-Pro Card.

*** USEF will now allow non-pros to give lessons for remuneration. (Erin Wieldraayer) Sylvia G moved to accept/ George C 2nd.

After discussion, George C moved to amend the motion to delete WSH shows accepting Amateur/Non-Pro cards from all other breeds. Amateur/Non-Pro exhibitors will be required to meet the WSH Amateur requirements and apply for/purchase a WSH Amateur card. Move section 2, paragraph 6 (pg 19) to replace paragraph 1. Heather F 2nd. Amendment approved and motion **Approved**, as amended.

3. A Professional is based on one's own activities. Unless expressly permitted above, a person is a professional if after their 19th birthday they do any of the following:

- a. Accepts remuneration AND rides, exercises, drives, shows, trains, assists in training, schools or conducts clinics or seminars.
- b. Accepts remuneration AND gives riding or driving lessons, showmanship lessons, equitation lessons, trains horses, or provides consultation services in riding, driving, showmanship, equitation, or training of horses.
- c. Accepts remuneration AND acts as an employee in a position such as a groom, farrier, bookkeeper, veterinarian or barn manager AND instructs, rides, drives, shows, trains or schools horses that are owned,

boarded or trained by their employer, any member of their employer's family, or a business in which their employer has an ownership interest.

d. Accepts remuneration AND uses their name, photograph or other form of personal association as a horseperson in connection with any advertisement or product/service for sale, including but not limited to apparel, equipment or property.

e. Rides, drives or shows any horse that a cohabitant or family member or a cohabitant or family member's business receives remuneration for boarding, training, riding, driving or showing. A cohabitant or family member of a trainer may not absolve themselves of this rule by entering into a lease or any other agreement for a horse owned by a client of the trainer.

f. Gives instruction to any person or rides, drives, or shows any horse, for which activity their cohabitant or another person in their family or business in which their cohabitant or a family member controls will receive remuneration for the activity. A cohabitant or family member of a trainer may not absolve themselves of this rule by entering into a lease or any other agreement for a horse owned by a client of the trainer.

g. Accepts remuneration AND acts as an agent in the sale of a horse or pony or accepts a horse or pony on consignment for the purpose of sale or training that is not owned by him/her, his/her cohabitant, or a member of his/her family, farm/ranch/syndicate/partnership, cooperation, farm/ranch/syndicate/partnership/corporation/business in which he/she, his/her cohabitant or a member of his/her family controls.

h. Advertises one's equestrian services such as training or instruction.

i. Accepts remuneration AND acts as an intern, apprentice, or working student whose responsibilities include, but are not limited to, riding, driving, showmanship, handling, showing, training or assisting in training, giving lessons/coaching and/or schooling horses other than horses actually owned by him/her.

j. Accepts remuneration in excess of rental fee for use of a facility, ring or school horses.

k. Accepts remuneration for such use AND uses commercial logoed items while on competition grounds unless expressly permitted by applicable division rules.

After discussion on para 'j': Pam K moved to accept as written/ Tina T 2nd. **Defeated** (para 'j' in the rulebook will **not** change)

Pg 19 - Section 2. Amateurs and Professionals:

5. There will be a one (1) year requirement for a Professional to relinquish their Professional status and be eligible for an Amateur status. The Professional shall send a letter of intent via certified mail to the Horse Show director. - a. To be shown in a regular type halter with only a longe line attached by the snap. A longe whip is permitted.
- b. Use of circle is necessary and should be 25 foot radius.
- c. Personal attire and appointments should be that of Halter or Showmanship. English prospects may be braided.
- d. Judge to be outside the longeing circle.
- e. At the signal each exhibitor will have 90 seconds to individually present his horse, starting in either direction. The horse should demonstrate a walk, jog/trot and lope/canter each direction. Playing on the line not to be penalized. This class is to reward movement, manners/expression/attitude and conformation. Judged as a pleasure prospect. May be penalized for excessive bucking, charging, or displaying traits undesirable in pleasure horses, (e.g., pinning ears or wringing tail).
- f. Bleeding, raw or broken skin will eliminate an entry.
- g. Exhibitors remain in the ring after showing.
- h. Judged on movement 60%; manners 20%; conformation 20% Balance and athletic capabilities are to be emphasized.
- i. Equines shown in longe line cannot be crossed entered into riding classes at the same show. May be shown in other in hand classes.
- j. An exhibitor will only show one (1) horse.

Change to Read:

Section 1. Longe Line 3 & Under

The purpose of showing a yearling on a longe line is to demonstrate that the equine has the movement, manners/expression/attitude, and conformation suitable to future performance. Judges are to evaluate movement based on the gait descriptions. A 25' radius circle should be maintained at all gaits.

- A. For the longeing demonstration, the only attachment allowed to the halter is a longe line. The longe line may not exceed 30 feet with a snap attached to the halter, retractable lines are prohibited. The longe line must hang free from the halter without touching any part of the equine. It is permissible to use a longe whip however, disqualification will occur anytime the exhibitor strikes the equine to cause forward or lateral movement at any time during the longe line demonstration.

- B. The class will consist of two parts: A conformation inspection and a longeing demonstration lasting one and one half minutes (90 seconds) showing all three gaits both directions.
- a. The score reflects the equine's performance on that day. Conformation, Jog/Trot, Lope/Canter and Manners/Attitude will be scored on the following basis ranging from +3 Excellent, +2 Very Good, +1 Good, 0 Correct, -1 Poor, -2 Very Poor, -3 Extremely Poor. The Walk and Use of Circle will be scored on the following basis ranging from +1 1/2 Excellent, +1 Very Good, +1/2 Good, 0 Correct, -1/2 Poor, -1 Very Poor, -1 1/2 Extremely Poor.
 1. **Walk.** The walk will be scored on a scale of +1 1/2 to -1 1/2 with 0 being average. Using a 25' radius, the equine must walk a minimum of two equine lengths for the judge to have sufficient time to evaluate and score the walk. Lower gait scores should reflect stumbling in the gait.
 2. **Jog or Trot.** The jog/trot will be scored on a scale of +3 to -3 in each direction, with 0 being average/correct. Using a 25' radius, the equine should jog or trot a minimum of 1/2 circle both directions of the ring. Lower gait scores should reflect stumbling in the gait.
 3. **Lope or Canter.** The lope/canter will be scored on a scale of +3 to -3 in each direction, with 0 being average/correct. Using a 25' radius, the equine should lope or canter a minimum of one full circle in both directions of the ring. Lower gait scores should reflect stumbling in the gait.
 4. **Use of Circle.** Scores for all gaits in both directions should reflect positive, consistent use of the 25' radius of the circle. Extra credit will be given for full, extended use of the circle on a slightly loose line. Lower gait scores should reflect lack of full use of the circle. Consideration will be given to how well or how poorly the equine/ exhibitor team uses the 25' radius of the longeing circle. A separate box on the scorecard is available to indicate an overall score from + 1 1/2 to - 1 1/2 with 0 being average/correct for use of the circle.
 5. **Manners/Expression/Attitude** will be scored on a scale of +3 to -3 in each direction, with 0 being average/correct. Equines will be penalized for obvious signs of overwork and sourness such as ear-pinning, head-throwing, striking, tail-wringing, or a dull, lethargic manner of going. They will also be penalized for dangerous behavior such as excessive bucking, cutting into the circle, or running off. Additionally, incidental touching the equine with the whip, cross-cantering, balking, backing up on the longe line and excessive urging from the exhibitor should be penalized accordingly.
 6. **Conformation** will be scored on a scale of +3 to -3, with 0 being average/correct. The equine will be judged on conformation suitable to future performance as a Western Pleasure or Hunter Under Saddle competitor. RULE 30 WESTERN DIVISION - PART A – WESTERN PLEASURE

Pg 133 – Section 10 (Note: this is actually Rule 30, section 1, para 10 at the top of pg 133)

Only split or romal reins are allowed when riding ‘Western’ – single piece closed reins or “roping reins” are not permitted. A bosal with closed reins and a mecate is also acceptable. ***Closed reins (example mecate) may not be used with a snaffle bit, except in working cow horse, boxing, ranch riding, ranch trail, all Versatile Ranch Horse (VRH) classes and, all Reining Horse Classes (RHC) classes, where a mecate is permitted. When using a snaffle bit in working cow horse, boxing, ranch riding, ranch trail, all VRH classes and all RHC classes, a leather or other woven material chin strap of any width is to be used and should be attached to the bit below the reins.***

Judged on performance 60%, conformation 30%, and appointments 10%.

PART D – RANCH HORSE

Pg 154

Propose to add to Ranch Horse (“SHOW RULED”; Above Section 1):

When riding with a romal in Ranch Horse Classes, a get down rope may be used. A get down rope is defined as a small rope tied around the neck of the horse with a bowline or other non-slip knot and run back to the exhibitor or tied to the saddle. The get down will be used to lead, ground tie, or tie the horse. When ground-tying with split reins, one or both reins may be dropped, romal reins may be loosely draped over the horse when used with or without a get-down rope.

This verbiage of tack is in some of the breeds and USEF.

Heidi B moved to accept / Angie A 2nd. **Approved.**

Page 155

Part D – Ranch Horse

Use as description of Ranch Horse:

The purpose of Ranch Riding horse should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse riding outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward and working speed while under control by the rider. Light contact should be rewarded, and horse shall not be shown on a full drape of reins. Allow posting and holding the saddle horn. The horses head position should be elevated and above the level at all gaits. The overall manners and responsiveness of the horse while performing the maneuver requirements, and the horse's quality of movement are the primary considerations.

Move these from Ranch Riding Open to Ranch Horse Description and renumber:

Posting at the jog is acceptable.

m. Touching or holding the saddle horn is acceptable.

n. Apparel and Equipment:

i. No hoof polish**

ii. No braided or banded manes or tail extensions. **

iii. Trimming inside of ears is discouraged. **

iv. Trimming bridle path is allowed, also trimming of fetlocks or excessive (long) facial hair.

v. Silver on bridles and saddles is discouraged and will not count over a good working outfit.

(will need renumbered) Two rein equipment will be allowed in Ranch Horse classes.

a. When using two rein, bosalita may be of any size, constructed of braided rawhide or leather and have a non-metal, flexible core. No iron or foreign substance may be used.

b. The rider must use one hand on the reins. Fingers between the reins will be permitted.

c. Both mecate and bridle reins are to be held in the rein hand.

d. All rules for two rein will follow hackamore and bridle requirements for the respective class.

(will need renumbered) GET DOWN ROPE. In ranch classes, a get-down rope will be allowed with the use of romal reins for the purposes of leading or working on the ground where required in the pattern. The get-down rope may be a neck rope or a neck rope with bosalita that is tied in a manner

that will not slide/tighten around the horse's neck. The tail end (lead) of the neck rope may be attached to the front of the saddle with saddle strings or run through the rider's belt loop but should not be tied to the saddle horn.

vi. It is suggested competitors use a breast collar and a rear cinch.

vii. Attire should be conservative in nature and reflect what would be seen on a working ranch.

Embellished western pleasure attire is not allowed. Chaps and chinks are allowed.

Sherri W moved to accept/ George C 2nd with the following adjustments:

Change "Two rein equipment" to "Two rein bridle"

The new section beginning with "Two rein equipment..." will be para vi.

The new section beginning with "GET DOWN ROPE..." will be para vii.

The current paragraph 'vi' now becomes 'viii'.

The current paragraph 'vii' now becomes 'ix'.

Approved.

Pg 157 – 158 (this should be Pg 154-155)

Section 1 Ranch Riding OPEN

Move to Ranch Riding Open Description and renumber:

Each horse will work individually, performing both required and optional maneuvers, and scored on the basis of 0 - 100, with 70 denoting an average performance.

b. Each maneuver will receive a score that should be added or subtracted from 70 and is subject to a penalty that should be subtracted.

c. Each maneuver will be scored on the following basis, ranging from plus 1 ½ to minus 1 1/2: i. -1 ½ extremely poor ii. -1 very poor iii. -½ poor iv. 0 Correct v. + ½ good vi. + 1 very good vii. + 1 ½ excellent. d. Maneuver scores are to be determined and assessed independently of penalty points.

e. The required maneuvers will include the walk, jog and lope in both directions: and the extended jog and extended lope in at least one direction; as well as stops and back.

f. Three (3) optional maneuvers may include a side pass, turns of 360 degrees or more, changes of lead (simple or flying), walk, jog or lope over a pole(s); or some reasonable combination of maneuvers that it would be reasonable for a ranch horse to perform.

g. The maneuvers may be arranged in various combinations with the final approval of the judge. h. The overall cadence and performance of the gaits should be with an emphasis on forward movement, free-flowing, and ground covering for all gaits. Transitions should be performed where designated with smoothness and responsiveness.

i. There is no time limit.

j. One of the suggested patterns may be used; however, a judge may utilize a different pattern as long as all required maneuvers and the three (3) or more optional maneuvers are included. Should a judge use one of his/her own patterns it is recommended to not have a stop following an extended lope.

k. The use of natural logs is encouraged.

Penalties to follow this section.

MUST leave NO CROSS ENTRY TO (3) GAIT CLASSES SAME HORSE RIDER COMBINATION.

Pam K moved to accept/ George C 2nd. **Approved.**

Ranch Rail Open (top of pg 159):

Change to Read:

Horses competing in Ranch Rail class should reflect the versatility, attitude, and movement of a working horse. The horse's performance should simulate a horse riding outside the confines of an arena and that of a working ranch horse. This class should show the horse's ability to work at a forward and working speed while under control by the rider. Light contact should be rewarded and horse shall not be shown on a full drape of reins. Allow posting and holding the saddle horn. The horses head position should be elevated and above the level at all gaits. The overall manners and responsiveness of the horse while performing the maneuver requirements, and the horse's quality of movement are the primary considerations. The class will be worked both directions of the arena. Exhibitors **may be** asked to walk, extend the walk, jog, extend the jog, lope, extend the lope, stop from any gait, back, side pass to and from the rail, and turn of 180 degrees or greater. Any class size greater than 8 may be worked in lots at show management or judge's discretion depending on arena capacity and safety. Sponsor Matt Olson

Then renumber the rest of classes

George C moved to accept/ Joy B 2nd. **Defeated**

Delete all references that 'require' judges to use score sheets and the scoring/penalties for the following disciplines:

- Equitation
- Trail
- Western Riding
- Ranch Riding

Suggest judges have the option to use the score sheets. Change "will" to "may" in all 'SCORING' areas

OR

Just include wording that makes using the score sheets optional. Change "will" to "may" in all 'SCORING' areas.

Rationale:

- Shows are minimally staffed and don't have the manpower to provide scribes

- If judges scribe themselves, it either adds time to do it or they are paying attention to the paperwork and not watching the exhibitor
- Exhibitors are not asking to see the score sheets

I realize a lot of effort went into creating these sections of the rulebook; I feel it should be left up to the judges as to what method they use to score the classes/exhibitors. Cheryl Moriarty

Joy B moved to accept/ George C 2nd.

After discussion, Joy B moved to make the scoresheets optional for 2025 while a different/better system is discussed/proposed. Tina T 2nd. 13 in favor/4 opposed. **Approved.**

House Keeping:

Rule 8 – Section 3 para 4 and 5 – Add – “Nominations must be to the Horse Show Director no later than October 5.”

Joy B moved to accept/ Tina T 2nd. **Approved.**

At approximately 4:30pm, the hotel staff needed the room to set up for the banquet. The question as to whether anyone had a burning desire to address any of the remaining rule changes at this time was asked; no one spoke up. It was suggested that any rule changes that were not covered this year go to the top of the list for next year.

When updating the Year End Awards form. Check to make sure the class names match what is in the Rule book. On the current Year end awards sign up:

Review the term “Prize List”

Does this need to be changed to “**Show Premium**” or “Premium List” or “Show Bill”?

There seems to be some confusion among some exhibitors that the term “Prize List” means that it is a list of the “prizes” that are going to be handed out by the show.

Review the following classes:

English Pleasure, Amateur, WT

English Pleasure, Open, WT

Western Pleasure, Amateur, WJ

Western Pleasure, Open, WJ

Trail Horse, E/W, Amateur, WT

Trail Horse, E/W, Open, WT

Ranch Horse Trail, Jr Ex Sr Ex Walk Jog

Ranch Rail, Jr Ex/Sr Ex Open Walk/Jog

All these classes prohibit cross entry into 3 gait classes by the same horse rider combination. There have been a couple of shows that have offered some of these classes. Even with the specifications in the show prize list exhibitors are still cross entering. This brings the problem that if it is the first class that they go in then they are no longer eligible for the 3 gait classes and should be disqualified. Same if they are in 3 gait classes prior to

these 2 gait classes they should be disqualified from the 2-gait class. I know the sponsor of the Amateur W/T created those classes to have true 2 gait riders in there not the 3 gait riders using it for a warm up class.

Have the specs available, posting eligibility put the no cross entry on the time schedule many of the exhibitors enter anyway. Do we remove the no cross entry to 3 gait by same horse and rider combination? I do not believe that all W/T & W/J classes should be able to cross, so that the true W/T horses and riders do not have to compete with the ones that are capable to do 3 gait classes.

Score Sheets: (This was verbiage received from a member and printed in the Canter; the 'optional' suggestion was addressed in one of the last rule changes covered.)

To make all references to the use of score sheets from mandatory to optional.

Have them available if the judges want them, and some do use them regardless.

As a person who puts on 3 shows a year with minimal staff, it is difficult to get people to commit or volunteer to scribe for the judges. Several judges scribed for themselves. That leads to paying more attention to the paperwork than watching the exhibitor execute the pattern/test for the class. In The Ranch Riding, Open at the KOS Show with 17 exhibitors, the judges averaged 2 minutes extra per horse with the score sheets and a scribe. That added an additional 34 minutes to the class. The same can be said for Showmanship and Trail.

Very few exhibitors ever ask to see them. I thought they were to be posted where exhibitors were able to view them.

General – several mentions of USE/Equine Canada/WSH ... should that be **USEF/Equine Canada/WSH?**

Other Business:

West Side – any further discussion

2025 Awards - Saddle – Erin's idea will be sent out via email and discussed on a zoom call.

USDA Guidelines for Horse Shows – Erin will email/post the current guidelines and keep the shows updated on additional information.

On November 12th, Erin emailed those who had attended the HSD meeting at convention and invited them to a zoom call on Tuesday, 19 November to cover the agenda items that, due to time constraints, we were not able to complete on 9 November. An invitation to the zoom meeting was emailed on 18 November.

The zoom meeting was called to order by Erin at 7PM.

Those in attendance were: Erin Wieldraayer, Tammy Call-Jones, Angie Argo, Kathy Norton, Tina Tomonelli, Joy Bjerke, Pam Kiehn, Heather Flores, Bonnie Schuchman, Michelle Weitman, Gloria Marley, Kim Lansing, Jole Chick, Dave Masengale and Cheryl Moriarty.

Pam K asked that we discuss the rule change that was proposed and approved at the convention meeting regarding Rule 30, Part A, Section 1, para 10 (paragraph that begins at the top of Page 133 and begins with “Only split or romal reins...”. At convention, the group voted to approve the change to read: “Only split or romal reins are allowed when riding ‘Western’ – single piece closed reins or “roping reins” are not permitted. A bosal with closed reins and a mecate is also acceptable. ***Closed reins (example mecate) may not be used with a snaffle bit, except in working cow horse, boxing, ranch riding, ranch trail, all Versatile Ranch Horse (VRH) classes and, all Reining Horse Classes (RHC) classes, where a mecate is permitted. When using a snaffle bit in working cow horse, boxing, ranch riding, ranch trail, all VRH classes and all RHC classes, a leather or other woven material chin strap of any width is to be used and should be attached to the bit below the reins.***”

Pam K did additional research after convention and found that USE and several breed organizations do not require a chin strap. If we go with the wording “...a leather or other woven material chin strap of any width is to be used...”, there will be multiple exhibitors who would automatically be DQ’d when they enter Western classes.

Pam moved to change the wording of this paragraph for the 2025 rulebook and request WSH Board approval at their January 2025 board meeting. With the change (underlined in the last sentence below), this paragraph would now read: “Only split or romal reins are allowed when riding ‘Western’ – single piece closed reins or “roping reins” are not permitted. A bosal with closed reins and a mecate is also acceptable. ***Closed reins (example mecate) may not be used with a snaffle bit, except in working cow horse, boxing, ranch riding, ranch trail, all Versatile Ranch Horse (VRH) classes and, all Reining Horse Classes (RHC) classes, where a mecate is permitted. When using a snaffle bit in working cow horse, boxing, ranch riding, ranch trail, all VRH classes and all RHC classes, a leather or other woven material chin strap of any width may be used and, if used, should be attached to the bit below the reins.***”

Tammy CJ 2nd. **Approved.** Erin will include the request for change in the January e-Canter and bring it to the Board.

West Side – further discussion.

There is an 18 December zoom meeting inviting those who are members and who currently reside in the zones that were combined to form the West Side Zone to discuss ideas moving forward. Several on the call said they would continue to watch for opportunities to hold WSH shows in their areas.

2025 Awards – Saddle

Erin shared an idea regarding awarding a saddle to the top rider. It would include the WSH logo on the fenders and would be contingent upon funding being secured by the time the saddle is ordered. In her research so far, she thought it would cost approximately \$800. Questions were raised as to what size & type of saddle it would be... Erin is suggesting a 16” seat & standard Schneider’s saddle. The lead time would be 8-12 weeks. Other ideas:

- Gift certificate rather than a saddle (it was felt that quite often trophy saddles are set aside and not used)
- Donation from Smart Pak was suggested, however it was stated that they typically expect a mailing list in return (which WSH has not allowed in the past)
- Vinyl signs to display on a horse trailer.

Pam K moved to pursue a sponsor for 1 trophy saddle/ Tina T 2nd. **Approved**

In addition, Erin asked for someone to research info regarding the vinyl signs and bring it to the January Advisory Committee meeting. Tina T and Gloria M volunteered to check vendors in their areas. It was suggested getting several estimates, i.e. 20" x 30" and 20" x 20" as a minimum.

USDA Guidelines for Horse Shows – Erin has sent what current info is available to all show committees; no other information has been distributed. She is continuing to review American Horse Council newsletters and updates and will forward when/if additional information come out. Her family farm attorney is also watching for info. What Erin has learned is that there will be a list of inspectors who are trained. It was suggested that folks write their federal Congressional representatives with their concerns/feelings.

There being no further business, the meeting adjourned at 7:35PM.
